A tax barrister can help identify key risks, deal with tax authorities in a manner which minimises reputational and financial risk, and ensure that an individual or business is prepared against the unexpected. Working closely with clients to ensure we avoid or minimise the risks and penalties to their businesses in both the short and long term is necessary in the legal field. In recent years, there has been a domestic and global trend of Governments shifting emphasis from direct to indirect taxation. Globally, while corporation tax rates have generally decreased, VAT rates have risen. Tax planning for landed estates (including business property relief and agricultural property relief) is a matter that a tax barrister can advise upon. A handful of United Kingdom tax barristers are able to undertake tax arbitrations either as counsel or arbitrator. Executive tax barristers advise clients on an appropriate tax planning strategy often working closely with our incentives team to implement the strategy in a collaborative and timely manner.



Practised barristers are briefed in matters of international tax law, income tax, capital gains tax, fringe benefits tax, payroll tax, land tax, stamp duty and state grants. Like other laws, tax laws are general legal prescriptions. However, a legal rule cannot

typically foresee all conditions of its implementation, so that ongoing interpretation (and frequently revision) of tax law is essential to its application. Some of the top tax barristers can advise on any matter involving penalties and tax assessments and will, where possible, provide you with fixed fee arrangements so that you know exactly what the costs will be to challenge HMRC. The most established tax barristers advise on the structure of joint ventures, developments and corporate real estate acquisitions as well as in the disposal phase. Highly Complex Tax Issues

The tax businesses pay is an important part of their wider economic and social impact and plays a key role in the development of the countries where they operate. In the UK, the legal profession is divided into barristers and solicitors. Barristers are generally known for appearing in court and providing expert advice in relation to specialist areas of law. A successful barrister is very balanced in their views and is someone who listens to and engages with those that instruct him. There are strict rules about what a tax barrister must do for the court and their client, and the way they must behave. Some barristers are able to accept instructions from advisers on behalf of their clients, businesses and individuals directly under the Public Access Scheme. This means that a client does not need to go through a solicitor or accountant in order to instruct them, although this may be recommended in some instances. In many countries the traditional divisions between barristers and solicitors are breaking down. Barristers once enjoyed a monopoly on appearances before the higher courts, but in Great Britain this has now been abolished, and solicitor advocates can generally appear for clients at trial. Most barristers are self-employed, but work in groups in what are known as "sets" of barristers' chambers, sharing premises and support services. More than a few UK tax barristers can help use CDR processes to resolve more quickly open enquiries and disputes or narrow down the differences in preparation for more efficient litigation. Technical merit is no longer enough. Some tax barristers focus on corporate tax matters, including transactions, corporate reorganisations and debt restructures.
